CHAIRMAN'S MESSAGE

How quickly the Climate conversation has escalated. From a WWF initiated Earth Hour in the 1990s to a Governments Climate Action Pact in Paris in 2007 to a youth led 16 year old Greta Thunberg Climate Day Strike and "How Dare You" speech to the United Nations General Assembly in September - clearly, Climate Change is now front and centre in the social and political arena.

WWF, still the largest and most recognisable environmental NGO in the world, calls it a "Planetary Emergency" and espouses a "New Deal for Nature and People". WWF's central mission is for People to Live in Harmony with Nature, and to argue that our Climate and Biodiversity crises cannot be handled separately.

Urgency and Scale have likewise impacted the Philippines, which has the dubious distinction of being the third riskiest country from a Disaster point of view, and the third largest Oceans Plastic Polluter in the world . And yet, Gen Z, or the Change Generation , feel that companies should address urgent social and environmental issues.

After several years of Revenue headwinds, WWF Philippines celebrated its 23rd anniversary with a record P 263 million in Receipts (82 per cent increase), primarily due to a European Union remote island electrification project. Meanwhile its Conservation team continued projects in the Food , Water, Climate, and Wildlife areas.

On the Governance side, WWF Philippines upgraded its external auditor to SGV and Co. Member voting procedures were refined and clarified, and management is in the process of seeking a renewal of its Philipine Council for NGO Certification (PCNC).

We thank the Dept of Tourism and the DENR, as well as our various corporate sponsors and LGU partners for supporting our Sustainable Tourism, Sustainable Food, and Sustainable Environment initiatives. We salute our Management team and our various Boards for their unfailing support of our cause. Finally, we must persevere as Climate Activists - as Al Gore says, "Solving the climate crisis is within our grasp - but we need people like you to stand up and act."

FISHERMEN BENEFITTING FROM MARINE PROJECTS


We worked with fishermen in Mindoro Strait and Lagonoy Gulf towards the improved management of fishery resource. Effective management and technological innovation in tuna fisheries across the country were also pushed and have resulted in the launch of the Mindoro Tuna Management Plan after three years of work.

In Northern Palawan, Northern Negros, Masbate, and Davao, we worked with local government units and national government agencies on marine protected areas and on food and livelihood security.



We continued to support the rehabilitation of Ipo Watershed, which provides 98% of the water of Metro Manila. 50,000 seedlings were planted across 112.5 hectares to aid in this effort.

In the Morong-Santa Teresa watershed, we're continuing to roll out a strategic framework plan to address increasing pressures in the area. We're also working on the development of a management plan for the Ara-al-Najalin Watershed in Negros Occidental.



This year saw the launch of projects that would promote and implement renewable energy. Meanwhile, 13 cities have joined the One Planet City Challenge, while Earth Hour saw a sizable load drop.

A program has been launched to electrify the four remotest island communities in Dinagat and Siargao with affordable and renewable solar energy.

WWF-Philippines continues to promote the use of renewable energy with the electrification of off-grid populations across the country through solar panels and charging stations.



Established in 2016 as the organization's youth arm, the WWF-Philippines National Youth Council has reached out to a total of 2,745,987 youth-individuals all over the country through social and print media, presence in youth forums and conferences, and their face-to-face school campaign entitled "PAMANA".

The NYC was able to connect with over 30 student-organizations from 30 schools, and mobilized them to participate in the Earth Hour, sustainability talks in schools, Global Climate Mobilization / Climate Strike, among others. With the past and current council members helping each other to spread WWF's message of environmental conservation and by sharing their personal advocacies, more young Filipinos are empowered to work towards a living planet for all.




With the #AyokoNgPlastik Movement, the Council continues to add businesses into its network through creative partnerships with stakeholders in various industries.

The No Plastic in Nature Initiative hopes to eliminate plastic pollution by 2030 through working with businesses, government, and the public. The initiative began with the launch of the #AyokoNgPlastik movement, now an online community of 7,660 members.


The Plastic Smart Cities project lobbies with local governments to keep plastic pollution to a minimum. We're working with Davao City and Donsol, Sorsogon to build a plastic-free future.



Work continued with WWF-Philippines' key species last year as we secure protected areas in Mindoro and Palawan.

The annual tamaraw count puts their number at 480, with new populations and individuals identified outside of Mts. Iglit-Baco National Park. In Donsol, whale shark numbers sit at 676, with an increase of 104 new individuals this year.

We've also renewed our commitment with the local government unit of Donsol with the signing of a MOA to commemorate 21 years of partnership.



Through innovative projects, WWF-Philippines has risen to demands of the times on the most pressing environmental challenges.

Our Sustainable Finance team is working with the finance industry, both local and regional, to streamline good environmental practices that will help green the financial scene and direct funding towards sustainable developments.

The Sustainable Diner Project continues to address problems of food waste, working with restaurants and hotels while lobbying with local and national governments to push for sustainability in dining.

We're working alongside the public to integrate renewable energy into the Butuan energy plan. Through workshops, the project is involving the public in the pursuit of clean energy.

WWF-Philippines works to improve Filipino lives by crafting solutions to climate change, providing sustainable livelihood programs, and conserving the country's richest marine and land habitats.

INDEPENDENT AUDITOR'S REPORT

The Board of Trustees Kabang Kalikasan ng Pilipinas Foundation, Inc.

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Kabang Kalikasan ng Pilipinas Foundation, Inc. (the Foundation), which comprise the statement of assets, liabilities and fund balances as at June 30, 2019 and statement of receipts and expenses, statement of changes in fund balances and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the statement of assets, liabilities and fund balances of the Foundation as at June 30, 2019, and its financial performance and its cash flows for the year then ended in accordance with Philippine Financial Reporting Standards for Small and Medium-sized Entities (PFRSs for SMEs).

Basis for Opinion

We conducted our audits in accordance with Philippine Standards on Auditing (PSAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Foundation in accordance with the Code of Ethics for Professional Accountants in the Philippines (Code of Ethics) together with the ethical requirements that are relevant to our audit of the financial statements in the Philippines, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other Matter

The financial statements of Kabang Kalikasan ng Pilipinas Foundation, Inc. as at and for the year ended June 30, 2018 were audited by another auditor who expressed an unqualified opinion on October 11, 2018.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with PFRSs for SMEs, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Foundation's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Foundation or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Foundation's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with PSAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with PSAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud
 or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that
 is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material
 misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve
 collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures
 that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the
 effectiveness of the Foundation's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and,
 based on the audit evidence obtained, whether a material uncertainty exists related to events or
 conditions that may cast significant doubt on the Foundation's ability to continue as a going concern.
 If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's
 report to the related disclosures in the financial statements or, if such disclosures are inadequate, to
 modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our
 auditor's report. However, future events or conditions may cause the Foundation to cease to continue
 as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the
 disclosures, and whether the financial statements represent the underlying transactions and events in a
 manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

Report on the Supplementary Information Required Under Revenue Regulations 15-2010

Our audit was conducted for the purpose of forming an opinion on the basic financial statements taken as a whole. The supplementary information required under Revenue Regulations 15-2010 in Note 19 to the financial statements is presented for purposes of filing with the Bureau of Internal Revenue and is not a required part of the basic financial statements. Such information is the responsibility of the management of Kabang Kalikasan ng Pilipinas Foundation, Inc. The information has been subjected to the auditing procedures applied in our audit of the basic financial statements. In our opinion, the information is fairly stated, in all material respects, in relation to the basic financial statements taken as a whole.
